

Municipal Borrowing Bylaw

For the Purpose Specified in Section 256/257/259/260 of the Municipal Government Act Bylaw No. 2024-004 WHEREAS the Council of Village of Halkirk (hereinafter called the "Corporation") in the Province of Alberta, considers it necessary to borrow certain sums of money for the purpose of: Line of Credit: Operating Expenses (MGA S256) Short Term Capital Borrowing (MGA S257) Interim Financing - capital projects and special projects. NOW THEREFORE pursuant to the provisions of the Municipal Government Act, it is hereby enacted by the Council of the Corporation as a By-law that: 1. The Corporation is hereby authorized to borrow from ATB Financial, ("ATB") up to the principal sum of repayable upon demand at a rate of interest per annum from time to time established by ATB, not to exceed 10%, and such interest will be calculated daily and due and payable monthly on the last day of each and every month. (Check The borrowing is a term loan repayable on demand and the Corporation is required to make, whichever payments of \$_____ each, for a term of ____ years. clause is applicable and initial) The borrowing is a line of credit repayable on demand and the Corporation is required to pay accrued interest monthly. 3. The Chief Elected Officer and the Chief Administrative Officer are authorized for and on behalf of the Corporation: (a) to apply to ATB for the aforesaid loan to the Corporation and to arrange with ATB the amount, terms and conditions of the loan and security or securities to be given to ATB; (b) as security for any money borrowed from ATB to execute promissory notes and other negotiable instruments or evidences of debt for such loans and renewals of all such promissory notes and other negotiable instruments or evidences of debts: to give or furnish to ATB all such securities and promises as ATB may require to secure (ii) repayment of such loans and interest thereon; and to execute all security agreements, hypothecations, debentures, charges, pledges, (iii) conveyances, assignments and transfers to and in favour of ATB ϕ f all or any property, real

or personal, moveable or immovable, now or hereafter owned by the Corporation or in which the Corporation may have any interest, and any other documents or contracts
